OFFICE OFADMISSIONS AND OUTREACH REFUND POLICY (2026-2027)

INTRODUCTION

O.P. Jindal Global University (JGU) is recognized as an Institution of Eminence (IoE) vide Gazette Notification dated 04 November 2020 by the Ministry of Education, Government of India in the year 2020. The University Fee Refund Policy governs the withdrawal and refund of fees to any student as per rules prescribed by the O.P. Jindal Global University (JGU).

IMPORTANT DATES

WITHDRAWAL REFUND POLICY

The officially notified last date of admission is 31st July 2026. Below are the Refund Details on Withdrawal of Admission by the Candidate:

- 1. If a candidate withdraws their admission on or before 16th July 2026, the candidate will receive a 100% refund on the entire Registration fees for the residential programmes, as deposited by the candidate.
- 2. If a candidate withdraws their admission from 17th July 2026 to 30th July 2026, the candidate will receive a 90% refund on the Registration fees for the residential programmes, as deposited by the candidate.
- 3. If a candidate withdraws their admission from 31st July 2026 to 14th August 2026, the candidate will receive an 80% refund on the Registration fees for the residential programmes, as deposited by the candidate.
- 4. If a candidate withdraws their admission from 15th August 2026 to 29th August 2026, the candidate will receive a 50% refund on the Registration fees for the residential programmes, as deposited by the candidate.
- 5. If a candidate withdraws their admission on or after 30th August 2026, **none of the tuition fees paid will be refunded.**

Registration Fee does not include caution money and security deposit. Caution money and security deposit will be refunded in full, if paid, irrespective of the date on which notice of withdrawal is received.

- O.P. Jindal Global University reserves the right to change, modify, add, or remove portions of the policy at any time by posting the amended policy on the website. Candidates are advised to check the policy periodically for changes.

PROCEDURE FOR SEEKING A REFUND

- 1. All requests for refunds must be received by the Office of Admissions and Outreach no later than 5:00 P.M. on the last deadline in each tier to be processed within that tier.
- 2. To apply for a refund, candidates must send a request to their respective Admission Counsellor and copy the same email to refunds@jgu.edu.in. This request will be treated as a notice of withdrawal and the amount of refund will be calculated as per the aforementioned table on page 2. Please include your Name, Programme, and Application Number in all communications. A request sent to any other email address, or through any other mode of communication e.g., WhatsApp, Text Message, over-the-phone call etc. shall not be considered valid.
- 3. Applicants for refunds may undergo an exit interview with a member of the Admissions Team before their application is processed. This interview is primarily for informational purposes and will in no way impact the status of the refund request unless the applicant rescinds the refund request.
