Purpose & Framework

Purpose : Deepen the study on Indian Statutory Regulatory Authorities (SRAs) to enhance public involvement and support

Framework: Scalable as a global index, especially for nations of the Global South

Periodicity: Annual

Target Audience: Policymakers, business and investors (global and domestic), and the larger citizenship interested in India's regulatory framework



Global Regulatory Framework

Global frameworks or indicators evaluate regulatory impact on economic environments

List sample frameworks:

US MCC – Regulatory Quality Indicator

OECD – Regulatory Impact Assessment (RIA) (Network of Economic Regulators)

IMD Lausanne – World Competitiveness Report

Innovate UK – Global Regulation Index

Cicero Institute – National Regulatory Reform Ranking



Development Plan & Key Considerations

- **SRA's Trust:** Establish confidence with SRAs for cooperation-outreach and stakeholder meetings
- **Industry Input:** Collaboration with industry chambers and stakeholders
- **Data Sources:** Access to private and public data is crucial
- **Focus:** Initial focus on central-level SRAs; possible inclusion of country studies/thematic annual pivots
- **Non-Ranking:** The report will not rank SRAs due to their diverse mandates

Project Stages



Scoping Report

- Establish causal chain and research methodology
- Bring in papers on regulatory themes
- Explore cross-country comparisons
- Update university faculty capacity
- Select list of regulators

First Annual Report

- Ascribe theme
- Seminars/open and closed-door sessions with experts from government, corporates, and academia at each stage

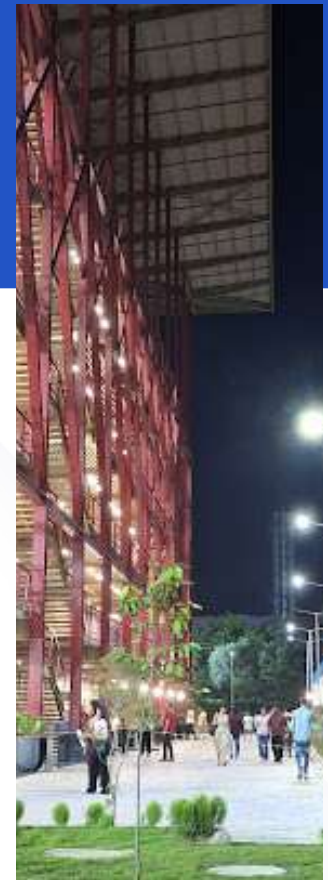

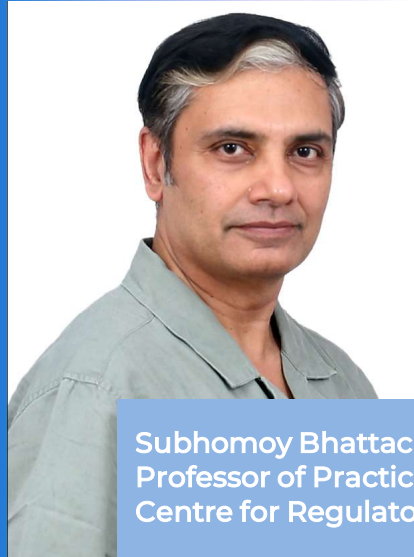
