Bio of Speaker

Dr. Orit Rozin is a senior lecturer in the Department of Jewish History at Tel Aviv University She is the author of *The Rise of the Individual in 1950s Israel: A Challenge to Collectivism* (2011) and *A Home for All Jews: Citizenship, Rights, and National Identity in the New Israeli State* (2016). Both published by University Press of New England and Brandeis University Press. Dr. Rozin is a visiting fellow at the Jindal Centre for Israel Studies in JSIA for February 2017. Her visit is jointly supported by the Embassy of Israel in India and the Asia Pacific Institute, American Jewish Committee.

Seminar Course Description

Since the declaration of the establishment of the State of Israel was read aloud by its first Prime Minister David Ben-Gurion, on May 14, 1948 in a modest ceremony, both state and society have known great changes. Yet the first decade of independence, formed the foundations on which state institutions stand until this very day. In Israeli collective memory these first days and years constitute the archive – from which both glorious events and dark shadows are occasionally brought into the daylight. Israel's past is an active battleground; politicians, veterans, historians and writers struggle over crafting a narrative. Former heroes become villains and those who feel they have been wronged, seek justice.

The course presents the legal, demographic, economic, and cultural as well as geo-political and security related pillars on which Israel stands today and also seeks to illuminate some of today's debates over past events.
