Dr. Anshukant Taneja is a distinguished finance professional with over three decades of experience spanning commercial banking, risk management, and impact investing across Asia. A Fellow of the Indian Institute of Management, Bangalore (1994) and a B.Sc. (Hons.) in Physics graduate from Delhi University (1988), he brings an exceptional blend of analytical depth and global financial insight to his work.

He began his career at CRISIL (a subsidiary of Standard & Poor's), where he honed strong analytical and appraisal skills in financial evaluation. His subsequent role at Infrastructure Development Finance Company (IDFC) in India offered exposure to complex financing structures and challenges from a lender's perspective. His tenure at ABN AMRO Bank NV, particularly in the Country Risk Office, expanded his understanding of corporate banking and risk management aligned with global best practices.

At Standard & Poor's Singapore, he served as Regional Head for South and Southeast Asia, broadening his regional and sectoral expertise in corporate and public finance. Since 2009, Dr. Anshukant has been associated with the Asian Development Bank (ADB), managing a diverse portfolio of impact investments across energy, financial, and social sectors. His work at ADB focuses on originating, structuring, and funding sustainable projects, while strengthening ESG capacities within client institutions.

Alongside his professional engagements, Dr. Anshukant has contributed to academia as a part-time faculty member at the Asian Institute of Management (Manila) and Ateneo Graduate School of Business, teaching courses in Advanced Financial Analysis and International Finance. He has also designed and delivered training programs at both Standard & Poor's and ADB.
