## HON'BLE MR. JUSTICE SUDHANSHU DHULIA

Justice Sudhanshu Dhulia was born on 10 August 1960, in Pauri Garhwal, Uttarakhand. He hailed from Madanpur, a village situated in the Pauri Garhwal district. His father, Keshav Chandra Dhulia was a Judge of the Allahabad High Court. His mother was a Sanskrit professor.

After completing his post graduate studies, Justice Dhulia completed his LL.B. in 1986 from Allahabad University. He then began his career as an advocate at the Allahabad High Court, where he practiced for 14 years. After the formation of the state of Uttarakhand in November 2000, he expanded his practice to the Uttarakhand High Court. In 2000, he was appointed as the first Chief Standing Counsel in the new state of Uttarakhand. He later became the Additional Advocate General of the state. In June 2004, Justice Dhulia was designated as a Senior Advocate of the Uttarakhand High Court.

In 2008, he was appointed as a Judge of the Uttarakhand High Court. During that time, Justice Dhulia authored 1119 Judgements and was part of 1415 benches. He continued to be a Judge at the high court until he was appointed as the Chief Justice of the Gauhati High Court on 10 January 2021. Here, he authored 81 Judgements and was a part of 110 benches. After serving for one year at the Gauhati Bench, Justice Dhulia was appointed as a Judge of the Supreme Court on 9 May 2022.
